As a person with type-1 diabetes, Abdullahi also is passionate about policies that ensure affordable health care and medication. After receiving her bachelor's degree in political science and international relations from The Ohio State University, she worked for local nonprofit groups for 10 years, advocating for youth, women and Muslim Americans.

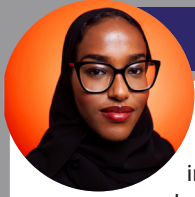
