Midwest Radioactive Materials Transportation Project (MRMTP) Status Report

2025 Annual Spring Meeting Melissa Shahzadeh, Project Manager (PM)

Items of Nate (Fall 2024 Annual Meeting to Spring 2025 Annual Meeting):

- The MRMTC held its Fall 2024 meeting in October 2024 in Bismarck, North Dakota. Ryan Seabaugh (MO) was elected as co-chair and replaced Tad Rumas (OH) who ended his tenure. Mr. Seabaugh will serve with Mark Paulson (WI) as MRMTC leadership. The committee voted to hold the annual 2025 Fall Meeting in Michigan.
- Our Community AnalySiS AND Readiness Aide (CASSANDRA) was successfully deployed at the Lucas County, Ohio Emergency Management Agency in July 2024. Members of police, fire, emergency management, and logistics were present. CASSANDRA was introduced to North Dakota's elected officials and EMA personnel in October. Various Federal Offices expressed interest in CASSANDRA and PM held various virtual meetings with officials during the final months of 2024 and the early months of 2025. The announcement of the transportation location of the High Burn Up Test Cask (HBUTC) has galvanised additional interest in CASSANDRA, and the PM is planning to deploy the Aide as widely as possible throughout the Midwest in the coming years. PM intends 3 CASSANDRA workshops in the Midwest before the end of 2025.
- The Regional Outreach Ad hoc Working Group completed its charge to develop a single sheet (front and back) flyer capturing the essential history of radioactive shipments in the US, the specific history of shipments in the Midwest, and the work of the MRMTC. The flyer was approved by vote in November 2024 and submitted to (and accepted by) the DOE that same month. A single-page infographic identifying the radioactive footprint within the American Midwest was surprisingly vexed but was also approved by vote in November. Both these documents are now housed on the MRMTP project resources web page and will be distributed to elected officials in the Midwest when CSG Midwest staffers engage in their "state visits" and meet individually with state representation. The work group was sunset upon completion of these tasks.
- The Regional Tribal Engagement Ad hoc Working Group has suffered from low interest and flagging participation. The Request for Information distributed to the MRMTC by the working group for local data on Tribal engagement was not returned by all Midwestern states. However, the data collected has been posted to the Public Resources section of the MRMTP. PM has decided to sunset the work group and will be seeking ideas for a new iteration of the effort at the spring meeting.
- PM continues to track developments in the US Army Corp of Engineers shipments of low-level radioactive waste from New York State into Southeast Michigan. There have been no developments since October 2024 when lawsuits were filed against Wayne Disposal Inc., the company that has accepted receipt of the waste. Wayne Disposal has cited the U.S. Constitution's Commerce

Clause in its notice to move the case to U.S. District Court of the Eastern District of Michigan. The company contends the clause "has long provided that 'the problems of waste disposal' represent 'a matter national in scope and in concern" and does not allow states or local governments to unilaterally stop shipments of out-of-state waste. The municipalities argue the landfill puts their residents in danger by disposing of waste with low levels of radioactivity. They said they were "kept in the dark" about the hazardous material and are not equipped to respond if the material escapes. As of October 2024, the judge presiding over the case has stopped shipments of TENORM waste – technologically enhanced naturally occurring radiological material – from the Niagara site but is permitting other radioactive waste to be imported from other similar sites. The annual fall meeting of the MRMTC will be held in Detroit, Michigan and PM has invited elected officials from Van Buren Township and local environs to participate in a panel discussion during said meeting.

- PM is tracking the restart of the Palisades Nuclear Plant in SW Michigan, and the federal concerns about what has been called a "very very aggressive" restart schedule, particularly in light of the repairs or possible replacement of infrastructure within the plant. PM is also tracking the operating license extension at the Monticello plant in Minnesota until 2050, which is at this point approved federally but still pending at the state level. And PM is tracking the total spent fuel liability in the US, which was reckoned at 37.6 billion at the end of 2024.
- The PM has begun to generate an excerpted, condensed rendition of the 2002 U.S. Department of Energy's "Final Environmental Impact Statement For a Geologic Repository for the Disposal of Spent Nuclear Fuel and High-Level Radioactive Waste at Yucca Mountain, Nye County, Nevada." The purpose is to retain the structure and language of the original but in an abbreviated form to achieve greater accessibility for a wider audience. Whilst minor edits are made in the interest of clarity, these should be considered an abridged reproduction of the original and can be used as a textual supplement to the DOE's "Reader's Guide and Summary." This abridged EIS is being produced in instalments. Chapter 1 Volume 1 and Chapter 2 Volume 1 is live on the MRMTP resource webpage.
